I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity. I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the Activity.

I hereby release, discharge, and covenant not to sue Olympic Warrior Gymnastic Academy, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "Releases" herein) from all liability, claims, demands, losses, or damages, on my account caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone of my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such claim.

OWGA TERMS AND CONDITIONS

- **TUITION is paid monthly and is due by the FIRST DAY OF EACH MONTH. A \$10.00 late fee will be added, if the tuition is not received by the 8TH. NO EXCEPTIONS. If tuition is not paid by the 8th your child/children will be dropped from his/her class until your account is current. Tuition can be paid at the front desk, by mail, or by phone. We accept cash, checks (made payable to OWGA), as well as MC and VISA.**
- **Returned checks are subject to a \$40 insufficient funds charge which will be added to your account.**
- **There is an ANNUAL REGISTRATION FEE of \$30.00 per child. There will be a charge of \$10.00 for additional siblings then remaining siblings free as long as two (2) or more children remain enrolled. This registration fee is non-refundable and must be paid at the time of enrollment along with the first month's tuition.**
- **DROPPING CLASS is permitted only with a WRITTEN NOTICE to the office 2 weeks in advance (phone calls or telling a coach is not sufficient). Drop Notices must be received 2 weeks prior to the 1st of the month that you intend on dropping OR YOU WILL BE OBLIGATED TO PAY FOR THAT MONTH'S TUITION. Please note that if the student temporarily drops from a class, his/her spot in that class will not be guaranteed at the time of re-enrollment. (Dropping relinquishes your spot in that class). Ex: if you want to drop Dec, must let front desk know by Nov 15. Please Initial: _____**
- **TRANSFERRING CLASSES is permitted so long as there is space available in the class you wish to transfer to and it is arranged at the front desk. Transferring classes is a privilege. Please do not abuse it. OWGA reserves the right to refuse transfers if and/or/when this privilege has been abused.**
- **HOLIDAYS, CLOSINGS AND CANCELLATIONS do not constitute a make-up day. OWGA reserves the right to cancel any class at any time. There are no refunds or credits for cancelled or missed classes, these classes are not guaranteed.**
- **Tuition is based on 4 classes a month. During the year there are some months that are 3 classes and some that are 5 classes. There will not be prorating for tuition if gym is closed for holidays or any other circumstance. It evens out throughout the year. They are however allowed ONE make up class a month, usually held at the end of each month.**
- **We are not responsible for any child before or after their class. DO NOT drop your child off more than 15 minutes before their class. Do not leave siblings, students, or friends unattended in the gym or lobby area at any time. Please be here to pick up your child on time and call the gym if you are running late to pick up. We are not responsible for your child once his or her class is over.**
